Policy and Criteria for Inclusion in the Registry

Each supervisor listed on the NASW-Illinois Chapter Supervisor Registry must meet the following criteria:

- Successfully complete the four-house Fundamentals of Clinical Social Work Supervision Course provided by the NASW-Illinois Chapter. Clinical supervision courses which are provided by continuing education sponsors other than the NASW-Illinois Chapter are NOT eligible for the purposes of this registry.
- Be a licensed clinical social worker (LCSW) in good standing with IDFPR at the time of listing in the NASW-Illinois Chapter Supervisor Registry.

The registry is sorted into two categories: Supervisors who are NASW members and supervisors who are nonmembers. It is then sorted in alphabetical order by the social worker's last name followed by first name.

Tip! While the best supervisor for you will be unique to you, we recommend using the "Control +F" function (search for a string of letters) and searching for either a supervisor in a city nearest you or by language/specialty.
